Background

The main purpose of Per and Lise Aarsleff's Foundation is to ensure the continued existence and further development of the Aarsleff Group.

In addition to the main purpose, the Foundation may provide support for charitable or non-profit purposes, including idea development, education, and research in technical fields.

On this basis, the Foundation has decided to allocate funding to help students in higher technical education programmes within the construction and civil engineering sector to acquire knowledge and skills abroad. The Foundation particularly wishes to support:

- Internships abroad for bachelor's and master's civil engineering students, architectural technology and construction management students, and mechanical engineering students within the construction and civil engineering sector.
- Study stays at foreign partner universities for bachelor's and master's civil engineering students, architectural technology and construction management students, and mechanical engineering students within the construction and civil engineering sector.

Applicants

The grants are awarded to the above-mentioned students enrolled at Danish institutions of higher education.

Key considerations include the student's personal motivation and willingness to move beyond familiar surroundings to gain insight into other cultures, and, more generally, whether the applicant demonstrates the energy and mindset to embrace personal development in an international environment.

Use of the grant

The grant may be used to cover expenses related to internships or exchange stays abroad. Support is not provided for participation in conferences and fairs.

The grant recipient must use the support for an internship or study stay aimed at gaining knowledge in one or more technical fields, as well as insight and practical experience from a company or university. The grants are reported to the Danish Tax and Customs Administration (SKAT) as tax-exempt, provided they are used to cover expenses related to an internship or study abroad.
